Subject to international travel restrictions being lifted, SelectUSA will also offer an in-person UAV/UAS Inbound Investment Mission to the United States. The week-long program will tour U.S. FAA Test Site locations to connect delegates with potential U.S. partners, experts, industry leaders, and government officials. Typically, the agenda in each city includes bespoke workshops designed to help delegates succeed in the United States. Delegates will find out how to scale in each U.S. location in the mission and learn about the resources and programs available to support their U.S. expansion strategy.
